



In 1683 Michaell (third son of Captain Anthony), and Anne Fulgham (his wife) deeded to the vestry of the lower parish of Isle of Wight county one acre of land from their estate on which the church (St. Luke's - "Old Brick Church") stood, standing by a deep swamp (Jone's Creek?). Michaell and several Fulgham family members are believed buried on this deeded property. This morning we will dedicate and present a new stone memorial in honor of the memory of Michaell Fulgham (ca1640-1690).

We welcome back the return of "From My Notebook" by Dr. Jim.





## Chesterfield Parish Church Processional Cross Repair

In the Fall of 1994, Mr. James Bolles, President of Ancestral Tours to Great Britain, Ltd., was in communication and at times on location with the Foljambes in Chesterfield, England regarding a tour for our Fulgham/Fulghum Family Association for 1995. He noticed an old processional cross that had been broken and tarnished at the Chesterfield Parish Church and asked of its historical value and possible restoration as a gift from the American family to our English cousins. It was found to be part of the antiquities of Wingerworth Church, a chapelry of Chesterfield some pieces dating to 1100 A.D. Sometime near 1600 the cross passed to the Chesterfield church by Major Hunloke under King William III as a relic. It was restored at least twice by 1923 with slight alterations and some missing parts were replaced correctly by examples in the British and South Kensington museums. Figures of the Virgin and St. John are on the brances above the symbol of St. Matthew in the base. In 1994, experts at the Victoria and Albert museum, goldsmiths of London and correspondence with Oxford University, were solicited by Mr. John Lockhard, the current P.C.C. Secretary of Chesterfield Parish. Soon, the cross was personally delivered to London restorers, Plowden Smiths (appointed to both the queen and queen mother). It was hoped that the cross could be restored and returned to the church to be re-dedicated at the time of the ancestral tour in June of 1995. The Rev. Peter Fulghum was appointed to solicit funds to pay for the restoration. Unfortunately, the royal restorers could not complete the repairs until January 1996 together with all legal and liturgical processes. Today, the Hunloke Cross is displayed in Holy Cross Chapel of Chesterfield Parish Church and will be used at the greater festivals of the parish revealing its 15th century beauty. The display case has been reinforced and an oak plinth on which the cross is mounted shows off its radiant beauty. The Fulgham/Fulghum Family Association is proud of the 18 families who donated funds to restore one of a handful of similar crosses remaining that links Chesterfield Parish and the famous Foljambe tombs to the medieval and prereformation periods.

#### A Brief Family History

Cousin Daphne Cross Arlington, Texas

Anthony Fulghum, son of Anthony, son of Michael, was married to Nancy Raiford. This would be our mutual grandfather. His son, Raiford, b: 1743, d: 1797, m: Winneford Pierce. They had eight children, Richard, Arthur, Theoplis, Benjamin, Rayford, and three daughters who are not named.



Franklin Christopher b: 1882, Laura Lilly b: abt 1877, and Helena b: abt 1875. Ella Elizabeth died March 16, 1882. An account in the newspaper clipping said that while walking the floor with her baby, (my grandfather's youngest brother Frank), she suddenly turned black in the face and collapsed. It did not make clear what caused this to happen. She died in Nacogdoches, Tx.

Arthur Fulgham m: Allice McKinnie, daughter of Wm. McKinnie and Mary Jernigan abt 1800. Arthur was born abt 1775 in Newbern Dist. N.C. He died Nov. 30, 1845 in Nacogdoches Co. Tx. Arthur and Allice had nine children, Pierce, Wm. Wilson McKinnie, Susan, Raford Frank, Richard M., Charlotte M., Carolina, Adaline, and Julia. Arthur and Alice, and their son Pierce came to Texas from N.C., they were all given land grants in Nacogdoches Co. Tx. Arthur and Alice were given 640 acres each by the Republic of Texas, and Pierce, being single at the time, was given 320 acres. They lived out the rest of their lives in Nacogdoches Tx. 1800 Census shows Arthur in Wayne Co., N.C. and 1830 census shows him in Hardeman Co. Tenn.

Pierce Fulgham was born 1806 in North Carolina. He died July 16, 1859 in Nacogdoches Tx. He married Hester A. Hines, parents unknown. Pierce and Hester had three children. Mary Fulgham, James A. Fulgham, and Amanda Fulgham. Pierce and Hester were married March 3, 1832.

James A. Fulgham was born September 4, 1835 in Giles Co., Tenn. and died May 8, 1872 in Nacogdoches, Tx. He married Mary Frances Rainbolt, daughter of Wm. Henry Harrison Rainbolt and Mary Smith Boyd. James and Mary Frances had five children, Ella Elizabeth, b: 1858, Married Wm. Darby Christopher September 4, 1873., James Fulgham b: 1861, Mary A. Fulgham b: September 1, 1865, Julia Ann Fulgham, b: June 28, 1868., Pierce (Bud) Fulgham, b: November 4, 1870.

Ella Elizabeth and Wm. Darby Christopher had four children., Robert Arthur Christopher b: 1880, Wm.

Robert Arthur Christopher m: Cora Lee Joiner, January 14, 1906. They had three sons, actually they had four, but the youngest died at birth. Their oldest son was my father Floyd Lee Christopher B: December 20, 1906. d: March 1, 1992. He married Jewell Wright in 1928. Floyd and Jewell had four children of whom I am the oldest. I have two younger sisters, and a brother who died in 1981 when his light plan crashed.

All of the Nacogdoches branch of Fulghams were highly respected and the holders of much property in the county.

\*Jesse Brantly Fulghum, is the local forbearer of this Tidewater root. He started in Rock Ridge, Wilson County, North Carolina on 29 August 1912; the sixth of seven children, (third son) of Jesse & Nona (Boykin). Jesse died on 5 May 1967 at Newport News, Virginia and is buried at the Peninsula Memorial Garden Cemetery. As a young boy, he attended Healthy Plains Primitive Baptist Church, and Marsh Swamp Free Will Baptist Church with his family. He attended the Lodge school near the Fulghum Settlement and then enrolled in the Rock Ridge School. He worked in various family, tobacco industry and farming enterprises in Wilson County, N.C. during his youth. Jesse & Helen (Evans) married at Emporia, Virginia on 18 February 1938. They reared four children as listed and were endowed with eleven grandchildren and seven greatgrandchildren. Jesse & Helen migrated to the Virginia peninsula with the family in 1947 to be close to this job building the SS United States at Newport News Shipbuilding. This migration brought a part of the family back to full circle closure - back to the origins of the Fulghums in the New World. His offspring now carry on in the Tidewater area and live life as many of the family forbearers have with hard work, family caring, and reunion hosting.
