## MAILING YOUR NEWSLETTER

### Why Your Newsletter may be Received Late

The Fulgham-Fulghum Family Facts newsletter is printed and mailed in Greenville, NC. It is sent via Presorted, Standard Mail. Our Presorted Standard Mail MUST be delivered by the US Postal Service or returned to Peggy Wood with an address change.

The mailings are handled by the US Postal Service Bulk Mail Centers. There is a Bulk Mail Center (BMC) in each state. The newsletters go to the Bulk Mail Center (BMC) in Greensboro, NC and are separated by state. Then the newsletters are sent to the BMC in your state. The routing from Greenville to Greensboro and thence to your state may be different than the routing for First Class Mail. Once the newsletters reach the BMC in your state, they are separated for distribution to your local address and usually go via the same routing as First Class Mail.

HOWEVER, the First Class Mail in the distribution to your address must be handled first, which often delays the Standard Mail. In addition, the complex routing to BMC's may also delay delivery of Standard Mail.

As an example of the complexity that delays delivery of the Newsletter, your Editor's copy is mailed with the others in Greenville, NC. It then goes to a mail center in Rocky Mount, NC, then to Raleigh, NC and finally to the BMC in Greensboro. After separation by states, my newsletter goes to the Richmond, VA BMC and then to Lynchburg, VA and finally to Danville. At each Post Office it may be delayed due to heavy First Class mail in the system. It often takes three weeks for my copy of the newsletter to reach me in Danville, VA.

Mailing the newsletter First Class Mail would more than double the cost for postage to FFFNA to over \$800/issue. You might remind your mail carrier and Postmaster that Standard Mail MUST be delivered. This is important to do by those receiving First Class Mail from the FFFNA but are *not receiving* the newsletter.

## HELP !

### Descendants of James Fulghum

Some of the descendants of James Fulghum (DB ID # 303) and Jane Harrison Fulghum of Georgia changed the spelling their surname to FulghAm.

Those we know of were Stephen Fagin Fulgh\*m and James Edgar Fulgh\*m. However, we do not know of others. We seek information regarding which others might have switched from the UM to the AM spelling as well as which descendants, if any, of those who switched from UM to AM kept the AM spelling and which went back to the UM spelling. We know of both switches and switch backs.

If you are descended from any of James and Jane Fulghum's children and you spell your name FulghAm, please let us know by contacting Robert S. Fulghum, Newsletter Editor. We need to resolve this and have the names in the FFFNA Data Base spelled as they are currently spelled.

The lineage of this James Fulghum is: Capt. Anthony (961) → Michael (965) → Anthony (974) → Anthony (533) → John (524) → Matthew (295) → James (303). Sons of James and Jane with issue were: James Edgar (335), William Gary (337), Stephen Fagin (339), and Charles Mallary (341). If any of these men were your ancestor, please let us if you spell your surname **FULGHAM**.

### LINEAGES of PERSONS in NEWSLETTER ARTICLES

Cousin J. Robert Boykin III has suggested that the lineages of people featured in the FFFF newsletter be listed with the article. This we will do. We will add the FFFNA Database ID number in parentheses by each name Where the database has no data on the person, we will note that.

J. Robert Boykin is not in FFFNA database. We know his Great great grandmother was Chelly Fulghum (593) and the lineage is: Capt. Anthony (961) → Michael (965) → Anthony (974) → Anthony (533) → John (524) → Jacob (527) → Chelly (593).

### **The FFFNA Database**

Grant Fulgham, FFFNA Archivist and Historian, reports that the FFFNA database has grown from 15,639 names in 2004 to its current number of 16,393 person records. All of these go onto Gencircles webpage and are available to the family as needed. See the link to our Gencircles webpage on our FFFNA Homepage (see back page for Internet address). There are many family lineages that are incomplete. We encourage every Fulgh\*m to check the database. If your lineage is incorrect or incomplete, we urge you to send the new data to Grant Fulgham

### **MAJOR FULGH\*M PAPERS FINDS**

During the past year, three major finds of papers, etc relating to the Fulgh\*m family have been located.

1) The Mildred Elizabeth Fulghum Rea papers at New Mexico State University, 2) The Dr. Fenton L. Fulgham's papers, and 3) the 1980's letters between Henry Miller and Henry Newton Fulghum at the University of Oregon. These papers represent a wealth of knowledge of the family life, occupations, times and locations in which these Fulgh\*ms lived. Some have pictures.

Undoubtedly, there are many other collections about Fulgh\*ms in private collections and in libraries. If you know of any such collections, please let Grant Fulgham know about them. Such materials are extremely valuable to historians and genealogists.

Currently, your newsletter editor is arranging and indexing the many letters, papers, genealogical notes of his father, James Hooks Fulghum, who contributed much to Fulgh\*m genealogical knowledge in the 1940's to the 1970's.

Family Bible genealogical pages and family history pages are very important documentation for genealogical work. If you know of any such materials, please consider giving them to the Fulgham-Fulghum Museum and Library. Send them or copies to J. Grant Fulgham, 2551 Corte Tela, Camarillo, CA 93010.

### **THE ROTHERHAM PLOUGH BY JOSEPH FOLJAMBE**

#### **THE ROTHERHAM PLOUGH**

Joseph Foljambe was born in Eastwood, Rotherham, South Yorkshire, England.

In the mid 1600s the Dutch attempted to make improvements to ploughs; however a capital improvement in the plough was the invention of the iron mould-board and landside by Joseph Foljambe from Rotherham who built and patented what was described as, the Rotherham Swing Plough, in November, 1730.

While not the first iron plough, it was the first iron plough to have any commercial success, combining a number of technological innovations in its design, and being lighter than traditional ploughs. It remained in use in Britain until the development of the tractor.

It was referred to as a swing plough, because no depth wheel was used, it was constructed from wood. The fittings and coulter were made of iron and the mouldboard and share

**ROTHERHAM PLOUGH CONTINUED** were covered with an iron plate.

This new design was more efficient as it was light and economical enough in draught to be drawn by a pair of horses.

Joseph Foljambe's was perhaps the first factory where a plough was produced on a large scale. For over 30 years this design proved very popular and was used extensively up and down the country, as well as abroad. One of these patented Rotherham ploughs was imported and used for some time with satisfaction by George Washington. On becoming worn, his plowrights were unable to repair it, as is shown in an extract from The Writings of George Washington, 1732-1799 in a letter to the merchant, Wakelin Welch of London.

## The Fulgham-Fulghum Family Foundation Scholarship

The Fulgham-Fulghum Family National Association has established a tax exempt foundation known as the Fulgham-Fulghum Family National Foundation (FFFNF). This Foundation has applied, and has been approved by the Federal IRS, for 501 (c) 3 tax exempt status.

What does this mean?. It means that anyone making a contribution to the Fulgham-Fulghum Family National Foundation can claim a tax exemption for the gift on his or her income tax return. This includes gifts in kind (such as artifacts for the Museum/Library, books, papers, etc. for the Museum/Library) as well as gifts of money.

As one of its activities, the Foundation will offer a new higher education scholarship each year to any applicant, whether or not they are related to the family. Applications are now being accepted for the academic year 2005 – 2006.

The 2005-2006 Scholarship consists of a \$500 cash grant to the successful applicant on a competitive basis among the 2005-2006 applicants. The cash grant is to be used for books, required supplies or academic tuition.

Eligibility includes being accepted to, or current enrollment in, a post-secondary academic or technical training program. Applicants may be high school seniors, or in any level of post-secondary vocational training or at any level of post secondary academic higher education leading to a certification or an academic degree. Need, as well as academic promise, will be considered in making awards. The Committee reserves the right to not offer a scholarship to any applicants. The deadline for applications for 2005 will be July 1, 2005.

Please fill in the application blank on the back of this sheet and submit it along with the other required items specified in the application blank as a single application packet. However, transcripts to be sent directly from your school to the committee can be received separately. Incomplete applications cannot be considered.

The applicants will be notified early in August of the results of the scholarship competition.

The lineage of our family group, William Enoch Fulghum (234) and Mabel Bryan Fulghum (274), parents of my mother, Mary Emma Fulghum (272), who married James Smith Mills, is now thought to be as follows: Captain Anthony Fulgham (961)→ Michael (965) → Anthony (974)→ Anthony (533)→ John (524)→ Matthew (295)→ John Glenn (207)→ Joseph Harrison (212)→ William Enoch (234)→ Mary Fulghum.(272) This makes my mother a 9<sup>th</sup> generation progeny of Captain Anthony.

Matthew Fulghum (295) was born ca 1775 in Dobbs (now Wayne) County, NC, the fourth child of John Fulghum (524), ca 1747-1825 and Sarah (Barden) Fulghum, ca 1750-1827. <sup>(1)</sup>

Matthew married Sarah Dickinson ca 1797 in Wayne County, NC. Sarah Dickinson was from the Fairfield District of South Carolina. <sup>(2)</sup>
