Dear Cousins,

In our last family association newsletter, I put forward some concerns, which I know many of you share, about how to move our association forward sustainably, and preserve our family legacy for future generations. A small number of you contacted me to express a willingness to help out, which I very much appreciate.

A number of suggestions were put forward:

1. **Hold family reunions every other year**, at least until the economic situation improves.
2. **Increase dues modestly** to cover the real ongoing costs of printing and mailing the family newsletters.
3. **Move the family communications online** as quickly as possible to save printing and mailing costs. Any family member who preferred to receive a printed copy could request to keep that coming, at least for the foreseeable future.
4. **Differentiate dues** between those receiving an email and those receiving a hard copy of the family newsletter.
5. **Create different levels of dues** to allow members to contribute at a higher level if they are willing and able.
6. **Form a family association sustainability committee** to do some strategic thinking about how to make our association more sustainable. This might involve studying what other successful family associations are doing in this regard, and adapting those strategies for our own use.
7. **Find ways to engage our younger family members.** It is certainly true that our elder members tend to have the greatest expertise and interest in genealogy, family history, and more time to devote to this important work. But if we are to be more sustainable, we must always be working to engage the younger generations.

These ideas and others are worthy of serious consideration, not only by our board, but by each of us as we consider the importance of the precious information and history we have gathered about our good family and kin over the centuries. I encourage each of you to discuss this with other family members to raise awareness of the need for action, and to engage the best of our selves in this worthy enterprise.

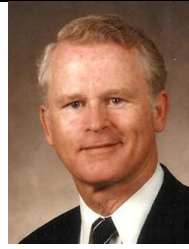

David Dowell Fulghum, MD age

73, died in Bradenton, Florida on June 3, 2011. David was the son of Charles Bennett Fulghum, MD and Elizabeth Moore Fulghum. He was born in Milledgeville, Georgia on November 7, 1937.

David married Ann Owen on June 11, 1960 in Milledgeville, GA.

David graduated from Georgia Military College, the University of Georgia and the Medical College of Georgia. He specialized in Dermatology. He served as a Captain in the USAF during the Vietnam War before he went into private practice in Bradenton.

David suffered a stroke that ended his medical practice in 1996.

He served as president for both the American Cancer Society and the Manatee County Medical Society. While serving as commodore of the Bradenton Yacht Club, he founded the Crosthwait Tournament. He served as a board member of the Florida West Coast Symphony and deacon at First Baptist Church of Bradenton. He was a Phi Delta Theta fraternity member and Rotary Paul Harris fellow. He was also a member of the Manatee County Blood Bank's Gallon Club, having donated over five gallons. David served on many boards and committees too numerous to list.

A man of many gifts, boundless energy and great honor, David looked for ways to invest in his community. While his first stroke ended his medical practice, it did not affect his desire to serve.

At that point David began leading medical mission teams to poverty stricken areas of Peru, Ghana, Mexico, Thailand, Venezuela and Haiti where he would often treat 100-200 patients a day. David fell in love with the Haitian people and established the ROME Foundation International to build and staff hospitals and clinics in suffering areas.

David leaves behind, Ann, his wife of 51 years, three children, Mark, Valerie, and Michael (Mark and Lisa Fulghum, Jon L and Valerie Morrison, Mike and Renée Fulghum) and seven grandchildren (Sarah and Matthew Talbert; Elizabeth, Motte Owen and Paige Morrison; Wyatt and David Fulghum). David was preceded in death by his parents and his brother, Charles.

The Rev. Dr. Fulghum Publishes a Collection of His Sermons

Charles Fulghum, an Atlanta psychiatrist, was ordained a deacon in the Episcopal Church in 1965 and a priest in 1984. When asked to preach, much to his surprise, his sermons, filled with anecdotes from his life and psychiatric practice, were well received. Encouraged to publish a book of them, through the years, he did save many sermon manuscripts. Now, in his retirement years he has published a small collection of them.

Charles states, "Over the years, my psychotherapy orientation has evolved from psychoanalytic to existential therapy. My psychiatric therapy means helping people to understand and accept the lonely and frustrating journey from birth to death. In church, my sermons teach why we need God and the church. If you already know all you need to know about life, God, and the church, these sermons are not for you, but if you still have a few questions about life and God, some of these sermons may resonate with your own quest for absolutes."

Editor's Note: Charles' sermons were helpful to me, particularly the sermon entitled ***A Sermon about Love***. In the Foreword to the book, Dr. Theodore Runyon makes some important theological observations and states, "... Charles Fulghum, by taking us into his congregation helps us with this book of his sermons" Dr. Runyon is Professor Emeritus of Systematic Theology at Candler School of Theology, Emory University, Atlanta, Georgia.

First Names and Naming Patterns in England

The conclusions of this article are based entirely on the findings of a book by Scott Smith-Bannister⁽¹⁾ of England based upon his dissertation for the PhD degree. Using the naming patterns disclosed in this study by Smith-Bannister, I have added a study of the naming patterns that can be perceived from the names of the first three generation descendants of Captain Anthony Fulgham. The objective of this study was to extrapolate these data to the possible names of the parents, godparents and/or grandparents of Captain Anthony.

In his quantitative study, Smith-Bannister used samples from the population of several shires and towns as samples to discern the patterns parents used to name their children, especially the first and second child. Using sophisticated statistical methods, he was able to discern the main patterns for naming children.

Prior to and after 1538, the date when church parish records were first required to be kept, Godparent's names were most often used to name the children – in fact, godparents, thus, controlled the naming of children and most often named them after themselves.

By the late 1500's, due to increasing motivation by the church, Parents were expected to provide the spiritual instruction formerly provided by godparents. Due to the importance of this role of parents, godparents had much less influence on the naming of children as parents accepted the role of spiritual teacher and advisor to their children. Thus patrilineal name sharing patterns (named after a male ancestor on the father's side of the family) came into increased use.

The use of surnames as a first or "Christian" name was not common in the Seventeenth century. Also, there appeared to be little difference in naming illegitimate vs. legitimate children in the mid to late Sixteenth Century.

First names have meaning. Children were expected to live up to the meaning of the name. In families where there was heavy duplication of a name, nicknames were often used to distinguish individuals.

The naming of a child after his baptismal sponsor (Godparents and/or parents) forged a link between the child and his/her sponsor. In the Elizabethan era about 20% of wills mentioned godchildren. This dropped to 3% by the 1680's.

Where the same name was given to living siblings may have been due to the naming of children after godparents; however, name sharing among children of the same parents was decidedly uncommon.

In the Sixteenth Century, 84% of boys were named after their godfather(s) whereas in the first two decades of the Seventeenth Century the proportion of boys named after at least one godfather dropped to 77% and continued sustained decline after 1620. This decline most probably resulted in less influence of godparents in naming children. The proportion of boys named after their father increased, especially in the southern parishes, resulting in a sustained move towards naming boys after their father. In conclusion, Smith-Bannister found progressively more

children were named after a parent between 1539 and 1700, with a 22% increase of male children named after a parent in the decade 1610-1620. The first born were more likely to be named after a parent.

Much less well-defined was the rise in the proportion of boys named after grandfathers. This, however, was not independent of trends in the name sharing practices of father – son.

Smith-Bannister says, "The most salient feature revealed by the close scrutiny of the most commonly used boy's names is a richly conformist tapestry of name patterning."

The most common first names for boys during the period 1600 – 1620 (as well as in all of the 16 decades studied for the first five names) were as follows:

1. John
2. Thomas or William
4. Richard
5. Robert

Further down the list for 1600 - 1620, we find:

11. Nicholas
12. Anthony or Matthew
16. Michael

The names of the sons of Captain Anthony Fulgham, in birth order, were: **John, Anthony, Michael, Nicholas**. The pattern of naming first and second sons in the first three generations of descendants of Captain Anthony in Virginia was as follows⁽²⁾:

Captain Anthony	Sons	Grandsons	GreatGrandsons

John and Michael adhered rather rigidly to the established patterns of naming children set out by Smith-Bannister.

Since the name of Anthony was in the 12th place in frequency, this may infer that Captain Anthony was probably not a first or second son. However, since Captain Anthony named his first son John, it is likely that the father or grandfather of Captain Anthony was named John (or perhaps his godfather was named John).
