## Russell Wendell Fulgham 1924 - 2013

Russell Wendell Fulgham, Age 90, died on December 17, 2013

Russell was born in Santa Ana, California on April 18,1924, the son of Fred and Jessie Fulgham.

Russell spent his early childhood in Oregon, moving to Grandview, Washington for high school.

A childhood leg injury kept him from joining the military. During WWII he served in the Civil Aeronautics Administration monitoring the skies and relaying weather information to military and civilian pilots in the remotest areas of Alaska.

Russsell was active in college life holding leadership positions in Alpha Kappa Lambda and the college Y.M.C.A. Russell earned a BA in Sociology at Washington State University in 1949.

Immediately after college, he taught school for two years in Forks and Sunnyside.

Russell met Joan Marie Cunningham while in college. They married in 1953He and Joan lived in central Washington where their first three daughters were born. Russ was employed as a case worker for the state Welfare Office. In 1961, they moved to Renton where their fourth daughter was born. From 1961 until his retirement on1984, Russ worked for the Social Security Administration in Seattle, Renton, and Bellview.

He was a member of the Wesley Memorial Church at Yakima, then in 1961 became a member of the Renton First United Methodist Church. As a member of the Renton Kiwanis, he chaired the 1974 Renton Air Fair. In retirement, Russ volunteered with the Special Olympics. For many years his white beard and twinkling blue eyes were admired by the children of his church and the Renton areas the real Santa Claus.

Russ was immensely proud of his Fulgham heritage, tracing his Fulgham lineage to its start in America in 1643, always willing to share his genealogical writings and information with every other Fulgham who would assuredly be a cousin.

Russ was predeceased by his parents and three siblings, Alberta, Lourene, and Edmond. In 2007, Russ lost his beloved wife.

Russ is survived by his youngest sister, Arlis Fulgham; four daughters Christine Fulgham, Katie (Howard) Rossbach, Marcie (Tim) Greggs, and Julie McNerney; seven grand children, Carrie, Steffie, Angela, Lauren, Laine, Max, Audry; four great grandchildren, Kylie, Lilia, Anthony and Michelle; and a loving extended family.

The family wishes to thank his wonderful caregivers in his final three years, Jenny, Diana, and Chip who treated him with compassion and respect; and Dr. Eric Seaver for his kindness and wisdom as a wonderful gentleman negotiated the perils of old age.

A celebration of Russ' life was planned for January.

Editors note: Russell Fulgham and my father, James Hooks Fulghum, never met that I know of but had extensive correspondence on Fulgh\*m genealogy. In 1970, Russ published *GENEALOGICAL NOTES ON THE FULGHAM-FULGHUM FAMILY*, a 25 page typewritten report on his genealogical work.

## MARTHA (GREENE) FULGHAM

Newsletter issue #76 of Winter 2014 discussed Anthony Fuljames/Fulgham's first marriage to Elizabeth Norris on 10 Nov 1638 in Pitminster, Somersetshire, England and the subsequent birth of their three children: John b. 1639, Thomas b. 1641, and Elizabeth b. 1643. The article noted that Elizabeth (Anthony's wife), Thomas, and Elizabeth (Anthony's daughter) disappeared from Somerset records after 1643 and they are presumed to have died. By 1647, Anthony was in what was then Northumberland Co. VA (a few years later part of Northumberland became Lancaster Co. VA) and he filed for a 500-acre patent on the south side of the east branch of the Corotoman River. It is believed to have been here that Anthony married his second wife, Martha Greene. Martha Fulgham has, until recently, appeared to us only vaguely, as if through opaque glass. It is the purpose of this article to explore the life of Martha Greene and the communities in which she played a part, both in her original home in England and, later, in Virginia.

### Saint-Giles-Without-Cripplegate, London Community

In the 17<sup>th</sup> century, St. Giles Cripplegate was perhaps the largest parish in what is now greater London. By the 17<sup>th</sup> century, Martha Greene's family, which reportedly descended from the Greenes of Green's Norton, Northamptonshire, had lived in Saint Giles Cripplegate for three or more generations. Her grandfather, father and uncles were merchants with their businesses centered there.<sup>2</sup>

Martha Greene's great-grandfather, John, was born in England about 1535 and was living in St Giles Cripplegate parish before 1568, the birth year of his eldest son, John. That John, Martha's grandfather, acquired the occupation of merchant, maintained the Cripplegate parish as his home, got married there in 1591 and sired four children: John b. 1592, Sara b, 1592 (a twin), Elizabeth b. 1594 and Robert (Martha Fulgham's father) b. 1598, all in St. Giles Cripplegate. A few of the famous residents of St Giles Cripplegate during this time, of which there were many, included William Shakespeare (he wrote Othello, King Lear, and other works while living there), Martin Frobisher (led three expeditions in search of the Northwest Passage) and Humphrey Gilbert (founder of the colony of Newfoundland).<sup>2</sup>

Virginia records show that John and Robert Greene involved themselves in Virginia commerce, maintained presences in both Virginia and St Giles Cripplegate and involved their adult children in their work. Robert Greene, Martha's father, first appeared in Virginia records in a census taken in 1619.<sup>3</sup> He had married Katherine Walker in St Giles Cripplegate on 9 Feb 1618 and she, and their first child accompanied Robert to Virginia in 1619. Robert appears to have patented land on this visit but he did not make a home in Virginia. He appeared as others' headrights in 1637 and 1658 and so it is reasonable to infer that he made at least three trips to Virginia by 1658. He and Katherine had eight children at St Giles Cripplegate: Robert b. 1620 (died young), Thomas b. 1621 (married Mary Moone; emigrated to lofW Co., VA), Elizabeth b. 1622, John1 b. 1624 (died young), Martha b. 1626 (married Anthony Fulgham, emigrated to lofW Co. VA), John2 b. 1627 (died young), Jane b. 1629 (married Robert Smith, emigrated to lofW Co. VA), Humphrey b. 1630. <sup>4</sup>

John Greene, Robert's older brother and Martha's uncle, first appeared in Virginia records as a headright in 1635 and, subsequently, at least twelve times between 1635 and his death in 1663. Each of the appearances as a headright signifies his immigration into Virginia from another country or colony. It is reasonable to infer that these were round trips between his home in St Giles Cripplegate and Virginia. We know that John had a daughter, Elizabeth b. 1626 (married William Hutchings ca 1651, emigrated to Lancaster Co., VA) and a son, John b. 1628. Both Elizabeth and John Greene appear as headrights in the land patent of John Weare of Silverton, Devonshire<sup>1</sup> (and others) dated 7 Sep 1654. John Weare and Anthony Fulgham had close familial connections and cooperated in seating their patents on the Corotoman River between 1647 and 1654. Weare and his family settled on the south side of the east branch of the Corotoman River about this time. One of the Virginia records showing John Greene, Sr.'s presence was a land patent for George Taylor dated 5 Sept. 1650 to patent land on the north side of the Rappahannock River on the south side of the east branch of the Corotoman River. Due to the typical 3-year lead time required to "seat" a claim for a land patent prior to its

execution, it is inferred that John Greene's immigration upon which the patent was based took place as early as 1647.

### **East-Branch-of-Corotoman-River Community**

The following colonists are believed to have been the earliest Virginian settlers taking up permanent residence on the south side of the east branch Corotoman River:

Since both John and Elizabeth Greene, Martha Fulgham's first cousins, appeared as headrights in the John Weare land patent of 7 Sept 1654<sup>5</sup>, and typically three years lead time passed before the patent was executed, it is reasonable to infer that they arrived in Virginia in about 1651. Often, more than three years passed before a patent was executed as planters accumulated headrights until desired land was available or the planter acquired an advantage by bartering the headright.<sup>6</sup> This is the case with Katharine Diamant's and Martha Greene's headrights which appear in Anthony Fulgham's Blackwater patent of 1664. Fulgham acquired indentures on Katharine Diamant and others in Bristol, England in 1655.<sup>7</sup>

A mini land-rush had begun about 1647 on the peninsula between the Potomac and Rappahannock Rivers, a region later known as the "Northern Neck" and which included the East Branch of the Corotoman Community. By 1650 the royalist forces in the civil war in England had sued for peace and many of its supporters immigrated to Virginia. Charles II, from his exile in France, had promised much of the Northern Neck to his supporters and this placed uncertainty on the land patents previously issued by the Virginia Land Office. The large movement of his supporters to Virginia came to be known as the "Cavalier Migration." John Weare is an example of a royalist supporter that emigrated to the Northern Neck by 1650. By 1654 Weare had purchased Anthony Fulgham's 500 acres and shortly afterward, Anthony and Martha returned to Anthony's original 1640 plantation on Pagan River in Isle of Wight County.

Anthony Fulgham's Pagan River plantation abutted south upon Captain John Moone's plantation. A year 1717 Isle of Wight County deed from John Fulgham to Nicholas Fulgham identified the Fulgham land as being on "the Red Point." Captain Moone died 12 Aug 1655 and bequeathed to his daughter, Mary Moone, "all land, etc., which lyeth on Red Pt. side now named Bethany ... and that lyeth by the King of all Places." Mary Moone married Thomas Greene, Martha Fulgham's brother, before 1657 and strengthened the continuing family affinities at Red Point among the Greenes, Moones, Fulghams and others. The following chart shows the primary Red Point resident families during Anthony Fulgham's lifetime:

It is seen from the above chart that Captain John Moone's three daughters each were bequeathed a plantation on or around the Red Point upon his death in 1655. Subsequently, when they married, they brought the plantations to the marriage as their jointure. Mary Moone received Bethany Plantation, including the "King of All Places", an anchorage or quay on Cypress Creek so-named in John Moone's will. She married Thomas Greene, Martha Fulgham's brother, about 1657 and it is reasonable to infer that they occupied the Bethany Plantation.

Anthony Fulgham's 1643 land patent<sup>5</sup> places his property "... south upon Mr. John Mahoone...." Robert Smith, Mariner, had married the widow Trayford (Jane Greene), Martha Fulgham's sister, in London in 1653, and lived as a tenant on Fulgham's property before 1669. John Browne, Shipwright, built the Sloop Isabella for Smith

on Pagan's Shore in the 1670's and it is deduced that Red Point's Pagan River and Cypress Creek side was a small ship maintenance and berthing location prior to that time.

Who was Martha Greene Fulgham? A picture has emerged of a daughter and kinswoman of Virginia merchants of St Giles Cripplegate in Stewart London. Beginning as early as 1619, and extending over ensuing decades her grandfather (John), father (Robert) and uncle (John) carried out business in Virginia maintaining multiple transient residences there. Martha's elder brother, Thomas, emigrated in 1639 to Lower Norfolk County and her 1<sup>st</sup> cousins, John and Elizabeth Greene, emigrated to Northumberland County (later Lancaster) in 1651, headrights of John Weare and his partners.<sup>5</sup> The exact year that Martha emigrated is unclear. If the reader will allow the author to speculate, she probably came over in 1651 when her cousins came over. Anthony had built a house on the Corotoman River and the Corotoman community was maturing by 1651. Martha's cousin Elizabeth had married William Hutchings there in about 1651 and they were living nearby. It is reasonable to infer that Anthony and Martha married soon after 1651. By 1654, Fulgham had reached agreement with John Weare regarding Weare's purchase of Fulgham's 500-acre Corotoman patent. Within the next year, Anthony and Martha had moved to his original Pagan River plantation in Isle of Wight County and he had made a trip to Bristol, England to arrange 36 headrights.<sup>7</sup>

The small Red Point Community that Martha Fulgham moved into in 1654/5 was a growing and bustling place. The King of all Places located on Bethany Plantation, from John Moone's will, would have been a reliable deep draft location for bringing ships in close to shore for loading. A warehouse would have been necessary for temporarily storing any cargo awaiting shipping. By 1657, Thomas Greene was managing Bethany and the landing. Nearby was Anthony Fulgham's plantation with rental facilities for Robert Smith (Mariner) and John Browne (Shipwright) for their shipping and ship building operations. Martha was neighbors with her brother, Thomas, and her sister, Jane Smith. All significant transportation in those days was by ship, whether for cargo or for passengers. If Martha needed to send a letter or package, or visit, her cousins in Lancaster County, she would have reached out to her brother-in-law, Robert Smith. It is speculated that the entire Greene/Fulgham/Smith enclave attended Sunday Services together at the Brick Church (St. Lukes), about 4 miles distance southeast from the upper Red Point. The minister of the Church of England officiating at St Luke's was Rev. Robert Bracewell between 1656 and 1667 and, subsequently, Rev. William Hudsden/Housden until 1680.<sup>11</sup>

Captain Anthony Fulgham died at age 54 in 1669 leaving Martha with three teenaged boys at home (John, aged 30 by 1669, had moved to the Blackwater patent in 1661). She did a good job rearing them and they all became good Virginia citizens and successful planters. Martha died after October 1678, when she was named in Anthony Fulgham, Jr.'s will, but there is good reason to believe that she died soon within that same year. Martha's father, Robert, died in London in October 1677, her mother, Katherine, died in London in January, 1678, her brother-in-law (and neighbor) Robert Smith died in August 1678, and her son, Anthony, Jr. died in December 1678. It is reasonable to infer that a contagion was spread within the family beginning in London. Although cemetery records have not been found, there is little doubt that Captain Anthony Fulgham, Martha Greene Fulgham, and Anthony Fulgham, Jr. are all three interred at St. Luke's Cemetery, Isle of Wight County, Virginia.



Anthony married first in Pitminster in 1638 to Elizabeth Norris and had three children by her, the oldest of whom, John, emigrated from England to Virginia with his father, Anthony. Anthony married secondly in Virginia in about 1655, to Martha Greene and had three additional children by her. See pages 5- 10 of this issue of the newsletter for an article on Martha.

The 16<sup>th</sup> Century Fuljames Family of Somerset, our ancestors, has not been well researched and there is a paucity of credible sources related to them. During the coming months, the Historian will be researching the family back through the 16<sup>th</sup> Century and further back with the goal of eventually merging with the findings of the published antiquarians related to the Fuljambe Family of Derbyshire. Fuljames arms are listed in Burke's "General Armory of England ... " as differenced from Foljambe for a younger branch. It is now reasonable to state that we are Foljambes and Derbyshire is our ancestral home."
