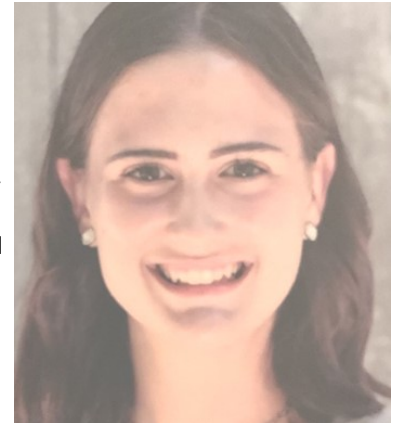

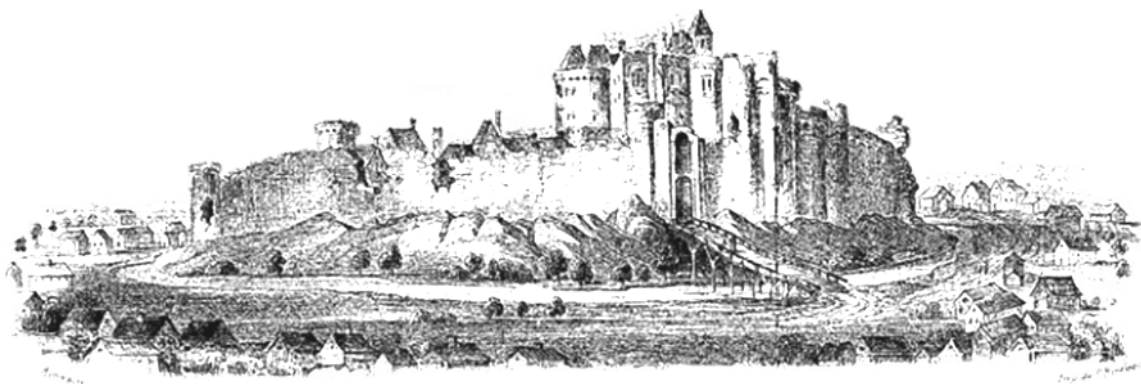
RICHARD FOLJAMBE “OF DARLEY” (ca. 1347-ca. 1389)**The 7G GRANDFATHER OF CAPTAIN ANTHONY FULGHAM****(continued from Issue 100)**

Upon Gaunt's return to Savoy Palace, planning and logistics activities continued on his "Great Chevauchee" against France with a projected year of invasion of 1373. After 1370, Gaunt appointed Sir Godfrey, Sr. Guardian for Joanna Montfort (nee Dampierre) "Of Flanders", Duchess Consort of Brittany, being held in protective custody at Tickhill Castle, Yorkshire under orders from Edward III. The reasoning behind her custody has remained obscure to the present day. Joanna of Flanders, whose Inquisition Post Mortem records her to have died at Hazelwood, Derbyshire, a Foljambe estate shown in the estate acquisition chart above, on 18 March, 48 Edw. III (1374) is an important figure in the 100 Years' War and will be discussed further in the biography of Sir Godfrey Foljambe, Sr. at a future date. Robert Foljambe, Esq. (1351-1409) another son of Sir Godfrey, Sr. and younger brother of our ancestor, Richard, served as a Man at Arms in the Expedition France under Sir William Windsor d. 1384 as Captain and Thomas "of Woodstock" Duke of Gloucester d. 1397 as Commander. Robert was registered June 28, 1380 in both muster rolls and retinue rolls and would have seen service in the aftermath of the War of Breton Succession in which his father's charge, Joanna of Flanders, played a major role.

Sir Godfrey, Jr. and his wife, Margaret Villiers, had sired a son, Sir Godfrey, III, in 1367. When Sir Godfrey, Jr. died under obscure circumstances in 1375, his only male offspring was his 9-year old son, Sir Godfrey III, who was unqualified by age to fulfill required feudal duties. The crown took the boy as its ward and, it is inferred, sold the wardship to Sir John Leeke of Leake & Cotham, Notts., who in 1386, following Godfrey III's marriage to his daughter, became the boy's father in law. We can only speculate about Godfrey III's upbringing and how he died at age 21. He may have prepared for the law similar to his grandfather and uncles, or he may have decided to become a soldier. Because of the work of his father and grandfather at the Savoy before and during Gaunt's "Great Chevauchee", perhaps he had contact with Gaunt. His date of death is in the same month and year as the shore raid by the 11th Earl of Arundel's fleet at Marans (near La Rochelle) Aug/Sep 1388.¹⁵ Arundel's fleet was under orders from John of Gaunt to apply pressure favoring his negotiations for peace with France. Gaunt and Thomas Mowbray, the Earl Marshal, were allied with the "Lords Appellant" at this time, however nominally favoring Richard II. Although Sir Godfrey III was buried at Bakewell Church, Derbyshire, no solid evidence has been found of his place of death. His Inquisition Post Mortem (IPM) clearly shows his date of death as 3 Sep 1388. Because of the close relationship known to have existed between Gaunt and his grandfather, as well as, indirectly, his father, Gaunt's authority over Arundel's fleet and Godfrey III's known date of death, it seems reasonable to draw the inference that Godfrey III may have been with Arundel in 1388 and may have been killed in the raid on Marans. The earl of Arundel lands his forces at Marans, near La Rochelle in Aug. 1388. The fleet remained for 15 days.¹⁵

William Foljambe "the feoffee"'s oldest son, Richard, Esq., served Henry V as a Man at Arms in the so-called French Expedition, which included the Battle of Agincourt in 1415. The historical record shows that Lord John Grey of Codnor was his Captain and that King Henry V was his Commander. His Muster Roll is dated 1417.¹² It is unclear what occupation Richard followed after his return to England. He was styled Esquire and he may have been involved as a gentleman farmer, with some legal work and perhaps politics. The historical record shows that his home was Bonsall, Derbyshire and, in 1434, he became embroiled in the English Midlands disturbance called the Foljambe-Pierrepoint Feud. James Foljambe, Rev., Esq. and Man at Arms, Richard of Darley's second son, was shown in the 1418 muster rolls under Thomas Beaufort, 1st Earl of Dorset (2nd Creation) who was his Captain and King Henry V his Commander in the garrison Harfleur, the former largest French naval base on the Seine, but in 1418 under English control.¹² 1418 was the year that Henry V returned to Normandy after Agincourt to pacify the rebellious French along the north coast. Thomas Beaufort brought over 300 men at arms and 900 archers mustered in his train to reinforce Harfleur which was in danger of falling to the French soon after Agincourt. James Foljambe appears to have mustered as a man-at-arms in this force for the duration of the garrison's mission. Thomas Beaufort's command of Harfleur perhaps should have ended with the signing of the Treaty of Troyes in 1420, however, the French remained rebellious and opened battle with Beaufort at Bauge, France in March 1421. Henry V died in 1422 and Beaufort was one of the executors of his will so Beaufort returned to England. It is certain that the English continued to man Harfleur at the level that existed in the lead-up to the Treaty of Troyes, however it is unclear what year James Foljambe was demobilized back to England. He was the Rector of Fenny Bentley in 1432 and some records have him as a chaplain as late as 14 Nov 1469 without listing a specific chapelry.¹⁶

SUMMARY - This article documented the life of our ancestor Richard Foljambe "Of Darley" (1347-1389)¹, the 7g grandfather of Capt. Anthony Fulgham. Richard's story is one of a younger son of a distinguished lawyer, judge, diplomat and MP from the high peak district of Derbyshire, Sir Godfrey Foljambe, Sr. Richard was probably born in 1347 in Dublin Castle, Dublin City, Ireland while his father was serving his king and country there on the Justiciar's Bench 1344-56.³

We know from the Foljambe Family Muniments that Richard was Sir Godfrey, Sr.'s 3rd son and that he sired two sons that lived, William and James.¹ Richard left us only a very sparse historical record but a quit claim deed that he executed with the Abbot of Buildwas Abbey for the possession of Ivonbrook Grange near Elton, Derbyshire in 1366 provides a clue to some level of legal education. The historical record shows that Sir Godfrey and John of Gaunt were involved in arranging legal education for Sir Godfrey's sons.⁹

Sir Godfrey, Sr.'s Inquisition Post Mortem of 1376 shows Richard (1347-89) to have been a joint heir of Darley Old Hall Manor with Godfrey, Sr., Avena, and Richard for the term of their lives with remainders to the right heirs of Godfrey, Sr. Unfortunately, Richard had only a life estate in Darley and at his death his heirs had no claim on it. His wife perhaps had a widow's claim on Elton from her first husband and so it is inferred that she, and her two sons by Richard, moved to Gratton Manor in Elton Parish.⁴

The Foljambe family was deeply involved in military activities in the Hundred Years' War. Richard's father, Sir Godfrey, Sr. was a trusted counselor to John of Gaunt, the supreme commander over all English and allied forces after 1369. Richard's youngest son, James (1386-1469), was a Man at Arms in Garrison Harfleur under Thomas Beaufort, 1st Earl of Dorset (2nd Creation)² as his Captain and King Henry V as his Commander.¹² Richard's grandson, also named Richard (1394-1434), by his elder son, William the feoffee, fought in the Battle of Agincourt with John, Lord Grey of Codnor¹² as his Captain and Henry V as his Commander. Richard carried the rank of Man at Arms and the status of Esquire in his military activities.¹¹

Charles "Blackie" Fulgham



Yazoo City - Former Yazoo City Mayor Charles E. "Blackie" Fulgham Sr., 93 years old, entered into glory on February 1, 2022, at home surrounded by his children. He was born in Drew, MS, on March 5, 1928, to Clarence L. and Lois Anthony Fulgham. He was the oldest of 7 children. "Blackie" was married to the love of his life for almost 66 years, Juanita Waltman Fulgham. He was a faithful and dedicated member of the Yazoo City Church of Christ, serving as a Trustee for many years. He loved his extended Fulgham family and served as President of the Fulgham-Fulghum Family National Association in 2000. He also loved his church family dearly, but most of all he loved the Lord Jesus Christ.

"Blackie" served as Sergeant First Class in the United States Army during the Korean War (1950-1952). He as served as an Alderman for the City of Yazoo (1971-1975). He was elected Mayor of the city he loved dearly, Yazoo City, and served for 12 years. Also, he served as President of the Yazoo County Chamber of Commerce (1976-1977), President of the Central

Mississippi Planning and Development District (1986-1987), President of Mississippi Municipal State Association (1989-1990), served on the board the Yazoo Community Action for Progress (1974-1990), President of the Rotary Club (1996-1997), and served as Bailiff for the Yazoo County Sheriffs Department (1996-2013).

He was preceded in death by his wife Juanita Waltman Fulgham, his parents Clarence L. and Lois Anthony Fulgham, brother Howard S. Fulgham, sister Madeline Fulgham Broadaway, and brother James Ellis "Doc" Fulgham.

He leaves behind his children, Charles Edwin Fulgham Jr. (Mona), Robert Michael Fulgham (Angelique) Glori Fulgham. His grandchildren Charles (Chas) Edwin Fulgham III, Mary Lauren Fulgham Howard (Matt). Meryl Fulgham Allen (Shane). SaraDent Fulgham Ledbetter (Joseph). Melanie Madden (Lou). Heather Russell Cobb. He is also survived by 13 great grandchildren and 1 great, great grandson and his sisters, Bonnie Jean Fulgham Strickland, Glenda Joy Fulgham Singleton (Bob), and Helen Fulgham Stewart (Quinn). Made By Jane Fulghum ca. 1885



A few months ago, our secretary, Carolyn Fulghum Allwine, received a nice email from Linda Barnes Cater. Linda included pictures and information on quilts made by Jane Fulghum, the sister of her maternal great grandmother Sarah Custis Fulghum Barnes (1867-1909). Linda has the quilts from Jane’s Hope Chest. Linda says Jane had a “fine sewing hand”! Unfortunately, Jane was killed in a buggy accident. She never married and the quilts were never used. Linda’s family has inherited the land near Rock Ridge that belonged to Sarah Custis Fulghum, Jane’s sister. Linda’s father was Robert L. Barnes, Jr. Her mother was Doris Lee Barnes Barnes who lived to be 103 years old, born, lived, and died in Rock Ridge, North Carolina. Linda tells us that all of the land from roughly a mile from “Rock Ridge” was Fulghum land at one time.

Reunions

The North America beginning of our family was in ISLE OF WIGHT County, Virginia in ca. 1640. Now we have reunions in many states. Of the 30 national reunions, the Association held the first in 1985 in Rock Ridge, NC. The last ten gatherings have been held 2006 in Nacogdoches, Texas; 2007 in Williamsburg, VA; 2008 in Raleigh, NC; 2009 at Smith Mountain Lake (Wirtz, VA); 2013 on St. Simon's Island, GA.; 2014 in Callaway Gardens; 2015 in Asheville, , NC, 2016 in Winston-Salem, NC. , and 2017 in Greenville, North Carolina. In 2017 the National Association voted to combine with the Foundation. The official name is the Fulgham-Fulghum National Family Foundation. The Foundation met in August 2018 in Richmond, VA .and in August 2019 in Raleigh, NC. Due to Covid 19 constraints in August 2020 and 2021 the Foundation met via Zoom.

One can find links to the FFNFF database in Rootsweb. Open our homepage and look for the link to Rootsweb in the left panel about the center of the first page. Click on the link to Rootsweb to access data and information on your ancestors and lineage.

Since much of the data on living persons are blocked for their privacy, it is easier to start the search using the names of a deceased ancestor.
