FOUNDATION HOLDS ANNUAL MEETING

Presents Peter Fulghum Plaque of Appreciation



Robert C. Fulgham, President, opened the Zoom meeting by recognizing Rev. Peter C Fulghum for his many years of tireless contributions to the Family. A plaque of appreciation was given to Peter and is pictured on the left. Robert summarized Peter's contribution with the following remarks:

BE IT KNOWN by this presentation from the officers and the Board of the Fulgham-Fulghum National Family Foundation on this day of October 11, 2022 that our beloved President Reverend Peter C. Fulghum who for over 40 years served as Vice President and President of the FFNFF and continues to serve as Scholarship Committee Chairman of the FFNFF.

Peter has been a member of the FFNFF since 1980. He attended the first national reunion in North Carolina in 1985.

At the 1989 reunion in Smithfield, VA, Peter along with Robert L. Fulghum (Author of All I Need to Know I Learned in Kindergarten) led the services at St. Luke's Church.

Peter was instrumental in having the Hunloke Cross dating from the 15th century restored as part of the antiquities of Winger Worth Church of England. Restoration was completed in 1996 and is on display in the Holy Cross Chapel of Chesterfield Parrish Church in England and will be used at festivals of the Parrish revealing its 15 century beauty.

Peter was also instrumental in soliciting 18 families who donated funds to restore a handful of similar crosses that links Chesterfield Parrish and the famous Foljambe tombs to medieval and the pre-reformation period.

In October of 1996 at St. Luke's Old Brick Church in Smithfield, VA, Peter officiated in early Angilcan vestments using Colonial Era prayer book references and music. A new memorial stone was unveiled for Michael Fulgham circa 1640-1690 at the cemetery.

In August of 1993, Peter solicited the Board of Directors to begin a fund for educational purposes for young family members. In 1999-2000 the first scholarship was given under our 501c3 tax exempt status.

In August of 2000, Peter looked into the possibility of establishing a Fulgham-Fulghum Family Museum within the St. Luke's historical museum but because of our limited funds it was decided to store the Fulgham-Fulghum Family artifacts at the Library of Virginia.

As a member of the scholarship committee Peter was selected as chairman and agreed to handle the applications and develop a selection process. In 2004-2005 the application went online and 604 requests from every state were received.

So it is with great pleasure that we dedicated this well deserved plaque to Peter for his tireless work and support throughout his 40+ years with the Fulgham-Fulghum Family Foundation.

Fulgham-Fulghum National Family Foundation Annual Meeting Minutes October 11, 2022



The Fulgham-Fulghum National Family Foundation met via Zoom on Tuesday, October 11 at 7:00 p.m.. Attending were: Robert C. Fulgham, Jr., President (and his wife Brenda); Andrea Fulgham Copeland, Vice President; Carolyn Fulghum Allwine, Secretary; Tom Fulghum, Treasurer; Grant Fulgham, Historian; Linda Fulghum Bruggemann, Newsletter Editor; Peter Fulghum, Scholarship Chairman; Carolyn Fulghum Schmersahl, Scholarship Committee member; Andrew Fulghum; Michael Fulghum; Paul Hughes (Towne Bank); John Cox, and Mary (last name not displayed by computer) Robert called the meeting to order and welcomed all attendees.

Robert recognized Peter as the Past President and read a list of his considerable contributions to the Family Foundation from its beginning 40 years ago. (Due to lack of space in this issue, we will publish these in a future newsletter.) Linda held up a plaque presented to Peter in appreciation for his many years of service to the FFNFF. The plaque will be shipped to Peter this week.

Approval of 2021 Annual Minutes

Motion was made to accept the August, 2021 Minutes as published in Issue 99 of the Family Newsletter. Motion passed.

Secretary's Report

Carolyn Allwine, Secretary, reported that the work continued on the Fulgham-Fulghum Mailing List. Tom Fulghum, Treasurer, and I set up a shared Microsoft Excel spreadsheet on Microsoft One Drive. (Thank you so much, Tom!) After each mailing, Tom updated the list with dues paid and I updated it with address changes received from individuals and the USPS. For each postal mailing, Tom sent the updated list with payment to Doug Mewborn at AccuLink. I sent out the email newsletters from my personal computer. For the most recent Issue 101 Summer 2022, 737 newsletters were mailed by USPS (with 14 returned as undeliverable, and 2 forwarded to new address by USPS) and 192 were sent via email (with 13 returned as undeliverable.)

I responded to several letters and emails from Fulgh*m cousins during the year.

Motion was made to accept 2022 Secretary's Report which was read here and sent to all officers via email. Motion passed. Report is attached.

Treasurer's Report

Tom Fulghum, Treasurer, referenced the Profit & Loss Statement and Balance Sheet, which are on page 6. The FFNFF account was transferred into an investment account with Raymond James Co. this year. We earned \$426 in interest this year compared to \$4 last year. This year the yearly dues received covered the yearly expenses. The donations to the Scholarship Fund exceeded the amount spent on the Scholarship. Tom reported that approximately 55 members paid their \$40 dues.

Paul Hughes, investment banker at Towne Bank, explained the investment process in the stock market. Our fund is tied to the US stock market, and since the market has been down this year, our total funds are less than last year. As the market rises, our funds will increase. Our money has been wisely invested by the fund manager and the best course is to wait until the market begins to rise, and we will see our account grow again.

Motion made to accept the Treasurer's Report. Motion passed.

Scholarship Report

Peter presented the Scholarship Committee Report. This year's scholarship winner is Mara Brown, recent graduate of Hempfield Area Senior High School in Greensburg, PA, who will be attending Indiana University of Pennsylvania this fall, studying nursing. Her biography is in Issue 101 of the Family Newsletter. There were 22 applications requested from 17 states, with 14 completed and returned.

Discussion followed about raising the amount of the scholarship to \$2000 or \$5000. Right now the economy doesn't lend itself to raising the amount to \$5000, but the group agreed (by motion, second, and vote) to increase the single scholarship to \$2000.

Peter will update the scholarship application form to reflect this change; Carolyn Schmersahl will update the Rootsweb site and scholarships.com sites; and Linda Bruggemann will put an announcement in a future newsletter.

Historian's Report: Review of Accomplishments in the Year 2022:

OUR ANCESTRAL MIGRATIONS –The FFNFF Historian has provided FFNFF Newsletter articles on the first immigrant to America (Issues #76 & #78). Additionally, articles have been provided which step us backward in time, generation to generation from the first Foljambe/Fulgham immigrant to his 7 G-Grandfather, Richard, the 3rd son of Sir Godfrey Foljambe (1316-76) and the final segment of Richard's biography was published in the family newsletter Issue #101. The FFNFF Historian recently completed preparation of an article for a future Newsletter issue on the 8G-Grandfather, Sir Godfrey Foljambe, Knt., Chief Justice of the King's Bench of Ireland.

THE FULJAMES CONNECTION – The year 2020 saw continuing research on our connection with the Somersetshire Fuljames family, specifically through the line of Anthony Fulgham/Fuljames' father, John. We have found that the Sir John Cotton, Knt., of Silverton, Devons. who m. Sarah Fuljames (Anthony's sister) descends from the Cotton family of Hamstall Ridware, Staffordshire. In 1428 a William of this line was born in Conington, Huntingdonshire and m. in 1441 to a Mary Folville, granddaughter of Agnes de Brus, a direct descendant of the Brus (Bruce) scot lords of Conington, Huntingdonshire. Work on the Fuljames connection has continued into 2022.

Maintaining the Family Database: OVER 46,489 PERSON RECORDS – Research into the English origins of our family has identified many previously unknown family members.

Grant also reported that he has corresponded with a young man in Texas who is very interested in genealogy research on the Fulgh*m family and hopes other young people will also develop an interest. He shared with the group that he has in his possession several scholarly works on the family history that Robert S. Fulghum, former Newsletter Editor, gave him. Some discussion followed about the origin of the Fulgh*m name from Normandy to England to the U.S. and from de Foleschamp to Foljambe to Fulgh*m. John Cox mentioned that there was some research indicating they had come through the Channel Islands.

Linda Bruggemann discussed the newsletter. She indicated that she would welcome input from other members in the form of obituaries, articles, clippings, and Family stories and news. Discussion followed about the size of the Newsletter. She reported that the eight page newsletter is most cost-effective from the printing and postage viewpoint.

Old Business

Robert reported that Historic St. Luke's Church in Smithfield, VA, had again contacted him about making a donation from the Fulgham-Fulghum National Family Foundation to the church and museum. Since the Fulgh*m family once owned the property and sold it to the church for a nominal amount, we are one of the historical colonial family groups connected to the church. Other family groups have made substantial donations. Discussion followed that our treasury cannot support a substantial donation at this time. Robert suggested that he contact Todd Ballance of the church to make a presentation to our Foundation in February or March 2023. Members present agreed to that suggestion.

New Business

Tom introduced the fact that the Bylaws of the Foundation are out of date and need to be revised. He will work on them and present changes at a Foundation ZOOM meeting to be scheduled in February or March 2023. Notice will be given at that time of a required meeting to approve them.

Nomination of officers

Robert agreed to remain President for 2022-2023.

Andrea Copeland agreed to remain Vice President for 2022-2023.

Carolyn Fulghum Allwine submitted her resignation as Secretary for 2022-2023, but agreed to remain until a new Secretary is elected.

Tom Fulghum agreed to remain Treasurer for 2022-2023.

Linda Bruggemann agreed to serve as Newsletter Editor again for 2022-2023 (but expressed a desire to retire from this position in the near future if someone can be found to take her place.)

Scholarship Committee members agreed to remain on the committee for 2022-2023.

Motion was made to accept this new slate of officers and passed.

Discussion followed about putting an article in a future newsletter and those following to let the members know that all positions are open every year and that anyone is eligible and encouraged to apply. Anyone interested in serving is invited to contact any officer to let the Board know of their interest. Email addresses are in every Newsletter.

All the attendees offered their thanks to Vice President Andrea Copeland for setting up and facilitating this ZOOM meeting. The formal part of meeting adjourned.

Social discussion followed with John Cox offering to be a resource to the Foundation. He has been attending meetings since the beginning of the Foundation and is still very interested in the Family, but is limited now due to failing eyesight and the illness of his wife. He brings a wealth of experience in many areas and was certainly interesting to meet. He asked if anyone knew of the whereabouts of Captain Anthony Fulgham's chair. He shared that it was once in the possession of Harold Fulghum in NC, but Harold is now deceased and Mr. Cox thinks it is now in the possession of Harold's daughter, Dell, who lives in Texas. He was unable to remember Dell's last name. Further research needs to be done on this. We will publish an inquiry in the Newsletter asking for information.

Discussion followed with Grant, which led to a request for him to conduct a ZOOM meeting every couple of months just to discuss the history of the Family with any members who are interested. He graciously agreed and Andrea will set up the first meeting when they coordinate a time. It will be advertised in the Newsletter.

Reunions

The North America beginning of our family was in ISLE OF WIGHT County, Virginia in ca. 1640. Now we have reunions in many states. Of the 30 national reunions, the Association held the first in 1985 in Rock Ridge, NC. The last ten gatherings have been held 2006 in Nacogdoches, Texas; 2007 in Williamsburg, VA; 2008 in Raleigh, NC; 2009 at Smith Mountain Lake (Wirtz, VA); 2013 on St. Simon's Island, GA.; 2014 in Callaway Gardens; 2015 in Asheville, , NC, 2016 in Winston-Salem, NC. , and 2017 in Greenville, North Carolina. In 2017 the National Association voted to combine with the Foundation. The official name is the Fulgham-Fulghum National Family Foundation. The Foundation met in August 2018 in Richmond, VA .and in August 2019 in Raleigh, NC. Due to Covid 19 constraints in August 2020-2022 the Foundation met via Zoom.
