Foundation Holds 2021 Annual Meeting and Elects New Officers

The family Annual meeting was held via Zoom on Saturday August 28, 2021 at 1 pm EST. As you know, we are required to have this meeting to meet the requirements to maintain our 501(c)(3) status. Details of the meeting follow in the Minutes from Carolyn Allwine and reports from other officers.

Annual Meeting Minutes



The Fulgham-Fulghum National Family Foundation met via Zoom on Saturday, August 28,2021. Attending were: Peter Fulghum, President; Robert Fulgham, Jr., Vice President (and his wife Brenda); Carolyn Fulghum Allwine, Secretary; Peggy Fulghum Wood, Treasurer; Linda Fulghum Bruggemann, Newsletter Editor; Tom Fulghum, Assistant Treasurer; Carolyn Fulghum Schmersahl; Andrea Copeland; Woody and Nancy Brown; Doug Fulghum, Sr.; Tina Roles, Meeting Coordinator. Peter Fulghum, President, opened the meeting with prayer and welcomed all attendees.

Secretary's Report:

Motion was made to accept the August, 2020 Minutes as published in Issue 96 of the Family Newsletter. Motion passed.

Treasurer's Report:

Peggy reported that dues were received from 51 Fulgh*m Family members. Some discussion about the report included an explanation of the Newsletter mailing amount. She explained that it had gone down a little and we have a \$24 credit right now. Carolyn noted that earlier this month 765 newsletters were sent via USPS and 174 were sent via email. Motion was made to accept 2021 Treasurer's Report which was read by Peggy and sent to all officers via email. Motion passed. Report is attached.

Scholarship Report:

Peter presented the Scholarship Committee Report. This year's scholarship winner is MaKayla Boyd, recent graduate of East Gaston High School in Mount Holly, NC. Her bio is in Issue 98 of the Family Newsletter. There were 23 applications returned from 15 states. He explained there are two elementary school teachers and one college professor on the selection committee. Peter serves as Chairman, but is not part of the selection process.

Discussion followed about raising the amount of the scholarship. We would like the scholarship to be self-perpetuating, but there is not enough money in the fund to do this. Tom explained the "risk vs. reward" of moving the fund into a money market account or leaving it in a solely interest-bearing account. Right now the economy doesn't lend itself to raising the amount, but we will research this. Peter mentioned the possibility of FFNFF members leaving a bequest in their wills to the Fund.

Historian's Report:

Grant was unable to attend today's meeting. An abbreviated report was given by Carolyn using Grant's emailed Historian's Report. Original report is attached.

Newsletter Report:

Linda Bruggemann discussed the newsletter. It comes out two or three times a year. The eight page newsletter is most cost-effective from the printing and postage viewpoint.

And not to have a newsletter without a tidbit from our Historian Grant Fulgham

The question is Did Michael Fulgham donate or sell the land for St. Luke's Church? Grant's answer: (He) Sold it for a nominal amount. It is speculated that the churchwardens wanted evidence that tangible consideration passed from the churchwardens to Michael. I'm uncertain if English contract law in the 17th century was the same as our modern contract law but we can surmise that it was. As such, current contract law requires that "consideration" must be tendered in order for a contract to be valid.



(In the previous issue we said "We want to know about you!" We asked that you share with us your experiences from December 7, 1941 and World War II. This year will be the 80th anniversary of that sad day.)

Memories of Pearl Harbor by Charles Edgar Fulghum, Greensboro, Georgia (Photo via Good Free Photos)

On December 7, 1941, I was 19 years old and living with my family in base housing at Carter Gate, Schofield Barracks, Hawaii. I had graduated from Leilehua High School in May and was working at the Base Exchange on Schofield Barracks that Sunday morning.

My father was in the US Army. He was the first sergeant of H Company, 21st Infantry stationed at Schofield Barracks He'd been assigned there in November 1940.



Very quickly, there were soldiers on the roofs of the barracks with weapons. I saw a soldier in the middle of the football field firing a 50 caliber machine gun. I was told they succeeded in downing one of the attacking planes.

My dad's workplace was near and very soon he found me at my building and told me to go find my mother and brother (13 years old). He tossed me the keys to the car and went back to work. I didn't know it then, but he and other soldiers were assigned duty on the beach to repel the invasion they expected. I can remember meeting ambulances on their way to the hospital, but I don't remember where I found my mother and brother. We stayed in the house the rest of the day.

That night, the Army took us into Honolulu to stay at a school. On the way we passed the harbor where the ships were still burning. The older boys were assigned sentry duty outside the school that night – they gave us night sticks to use to guard the building!

The next day, they dug fox holes in our front yard to use in case of another attack. We put blackout shades on the windows to prevent any light leaking through. I worked in the hospital as an orderly for several days, along with the other older dependents, then was transferred to the motor pool as a driver to free up military personnel.

I came back to the US in April, 1942 with my mother and brother on the British ship Aquitania. We landed in Long Beach, California and traveled by train to Higgston, Georgia.

I attended Anniston Air Craft School in Nashville, TN and upon completion worked at Tyndall Field in Panama City, FL until I entered the US Navy in November, 1942.

From Margaret Menefee Gillum, Nashville, TN

I was in third grade on December 7, 1941. I was listening to the radio with my parents that day when we heard the announcement that Pearl Harbor had been bombed. I remember that my parents were upset. I continued on through elementary school during the years of World War II. (Margaret is the daughter of Albert Leo Menefee and Mary Fulghum Menefee.)

From Peter Fulghum, Smithsburg, MD

On Dec 7, 1941 the Japanese air fleet bombed our naval ships at Pearl Harbor. I remember that day. I was sitting on the old wooden steps in the back yard with my brother Jimmy at my grandmother's house in Macon, Georgia at 109 Rogers Ave. I was 6 years old. My brother Robert came out swinging the old screen door wide and yelled out "The Japanese have bombed our naval fleet and they are coming to bomb us next." I was frightened, cried and went in the house where my Aunt Lillian and grandmother Frances consoled me a bit but I knew it was serious and wondered how we would survive this as a country now drawn into war.

We would like to honor the memory of these family members.

In June of 2021, I received an email from Woody Brown in Savannah: "A couple of weeks ago, our pastor referred in his sermon to a lady, Dolly (or Dollie) Fulghum, who helped him when he was a pastor in Springfield, GA. He spoke very highly of her. I asked him later if he could tell me more about her. Her husband was Charles Fulghum, who died over ten years ago, and Dolly died within the last three or four years. I couldn't find them in my Fulghum database. Do you know anything about these folks? "



(picture copied from the Effingham Herald, 1960) **Dollie Brinson Fulghum,** age 90, passed away Saturday January 23, 2016 at the Effingham County Care Center.

Dollie was born in Egypt, Ga. on July 4, 1925 to the late Fred Cornelius Brinson and Julia Harmon Morgan Brinson. She moved to Springfield, Georgia in the late 1930's and became an integral part of the Springfield community. After graduation she went to work with the Central of Georgia Railroad. Several years later she began working with Hester Motors where she was a long time loyal employee. Hester Motors sold and she went to work for Dan Vaden Chevrolet until she retired.

She was a very committed Christian and was an active member of the Springfield United Methodist Church. Her life revolved around her church activities. She and her husband were very involved in the Lay Witness Movement traveling to many churches to share God's love. She was a member of the Bible Studies Sunday School Class and was instrumental in starting a prayer ministry that continues to meet every Tuesday morning at 6:00am. She had the gift of ministry and compassion and always looked for ways to serve others.

Dollie was awarded the John Adam Treutlen Award from the Effingham County Chamber of Commerce in 2010 and was inducted into the Effingham County Sports Hall of Fame in 2008. She played basketball and softball as a young lady and still remained an avid sports fan always willing to discuss basketball or any other sport.

She was affectionately known as Aunt Dollie, Grandma, or "just plain ole Dollie" to all who knew her. She definitely made a difference in many people's lives.

She was preceded in death by her parents, her husband Charles (Charlie) B. Fulghum, Jr. and her sister Frances Willis.

Survivors include four nephews and one niece, Dr. William F. (Alice) Willis of Alburquerque, N.M., Ernest N. (Kim) Willis of Chaparral, N.M., Mark (Lisa) Fulghum of Palmetto, FL, Michael (Renee') Fulghum of Brandenton, FL, Valerie (Jon L.) Morrison of Bradenton, FL and sister-in-law Ann Fulghum of Bradenton, FL. Great nieces and nephews, Brinson Willis, Salem (Rich) Willis, Kourtney (Arron) Johnson, Matthew Talbert, Sarah (Jordan) Owen, Wyatt and Davis Fulghum, Elizabeth, Motte, and Paige Morrison.

Interment will be in the Springfield Cemetery.

Following his time at Boston University, Greg spent a long, productive career at MIT's Media Lab where he served as Facilities Manager, retiring in 2015. Greg was particularly proud of his contribution to the construction of the MIT Media Lab Complex opened in 2009, which involved much enjoyed trips to Japan to consult with Maki and Associates, the architects for the project.

A skilled pianist and guitarist, Greg continued to perform throughout his life, often accompanying his wife Sally on on flute. After discovering the rich local scene in traditional Irish music, Greg quickly proved himself a skilled backer on guitar and was a welcome participant in local sessions, playing regularly at both The Snug in Hingham and The Tinker's Son in Norwell.

Greg was an avid outdoorsman and enjoyed hiking and backpacking in all conditions and seasons, from the heat of the Nevada desert to the 20 below cold of the Adirondacks. In recent years, he came to appreciate more and more the intimate beauty of places close to his Hingham home, particularly the Trustees' properties at Turkey Hill and World's End, and in warmer weather could often be found plying local coastal waters and rivers in his kayak.

There will be a small, private meeting of the family at this time. A remembrance and celebration of Greg's life will be held at a later date for all friends and colleagues to attend.

Reunions

The North America beginning of our family was in ISLE OF WIGHT County, Virginia in ca. 1640. Now we have had reunions in many states. Of the 30 national reunions, the FFFNA held the first in 1985 in Rock Ridge, NC. The last ten gatherings have been held 2006 in Nacogdoches, Texas; 2007 in Williamsburg, VA; 2008 in Raleigh, NC; 2009 at Smith Mountain Lake (Wirtz, VA); 2013 on St. Simon's Island, GA.; 2014 in Callaway Gardens; 2015 in Asheville, , NC, 2016 in Winston-Salem, NC. , and 2017 in Greenville, North Carolina. In 2017 the National Association voted to combine with the Foundation. The Foundation met in August 2018 in Richmond, VA and in August 2019 in Raleigh, NC. Foundation meetings in 2020 and 2021 were held by the use of Zoom.
