The Fulgham Family and St Luke's Historical Church



Captain Anthony Fulghum (circa 1615-1669) emigrated to Virginia from Pitminster, Somerset UK around 1643 during the English Civil Wars. Somerset was a heavily Puritan area while the Fulghams had a connection to the established church via a marriage into the family of the Bishop of Exeter, William Cotton.

A son of Captain Anthony, Michael Fulgham, Sr. (1654-1691) owned land that was connected to his wife Ann's family, the Izards. One acre of this land was sold to the Lower Parish (Isle of Wight) in 1683. deed suggests that on this land was a "church house" or glebe (house and land for minister of the parish).

On this one acre was built the "Old Brick Church," now known as St Luke's, and was completed by 1685/86. The construction of the building was largely due to the beneficence of Col. Joseph Bridger of White Marsh Plantation. Interestingly, a brother of Michael Sr, Anthony Fulgham Jr was implicated in Bacon's Rebellion. Bridger was one of those responsible for putting down the Rebellion.

A marker commemorating Michael Fulgham Sr was placed west of the church building.

SIR THOMAS FOLJAMBE IV, b. ca. 1284-d. ca. 1331**The 9G GRANDFATHER OF CAPTAIN ANTHONY FULGHAM**

INTRODUCTION - This article explores the life of our ancestor Sir Thomas Foljambe IV (1284-1331), Lord of Tideswell and Wormhill, Knight of the Shire for County Derby, sometime MP for Derbyshire and the recognized Foljambe family patriarch 1327-1331. He is given the numeral IV because he is the fourth generation Sir Thomas Foljambe family patriarch since the first Sir Thomas b. ca. 1207.¹ Prior FFNFF Newsletters #103-4 provided key facts about the immediate family and descendants of Sir Thomas IV and so for brevity this introductory discussion will focus primarily on his ancestors. Sir Thomas IV's father, Sir Thomas III lived 1256-1323 and flourished during the reigns of Henry III, Edward I & Edward II. Sir Thomas IV's mother was Alice de Furnival, of the Furnival lords of Hallamshire and Sheffield, Yorkshire West Riding. Alice was the daughter and co-heiress of Gerard de Furnival 1236-1302, who had the Munden Furnival estate in Hertfordshire.² Gerard's wife...Alice's mother, was Joan de Morville 1236-83 of Burgh-by-Sands (AKA "Burgh"), Cumberlandshire. Joan's grandfather, Hugh de Morville, Baron of Burgh, was the last Morville to inherit Burgh in toto and the first to break it into moieties (two or more equal parts) upon his death, which occurred in 1202. Hugh's only son, also named Hugh 1196-1269, received one half-moiety of Burgh and his sister, Joanna Gernon (nee Morville) wife of Richard Gernon, sheriff of Cumberland, received the second half-moiety. At Joanna's death in 1247 her half-moiety was broken into two smaller ¼ moieties which were bequeathed to her heirs. Meanwhile, the Hugh Morville (NOT the Constable of Scotland under King David Fitz Malcolm) who received a half-moiety of Burgh in 1202 had married Beatrice Beauchamp 1219-67 (NOT the heiress of Houghton Conquest, Beds.) in 1234 and they had an only child, Joan, in 1238. Joan married the Gerard Furnival mentioned above of Munden Furnival in 1252 and they ultimately had five children. Although Hugh Morville of the ½ moiety died in 1269 it remains unclear if he bequeathed it to his only child, Joan. The record is obscure on that point. However, his sister, Ada Morville, married the Justiciar and lawyer Sir Thomas Moulton (m. 1218), they had a son, Thomas (AKA Thomas II de Multon in Wikipedia) styled "Baron of Burgh" who lived 1220-71, and Burgh by Sands later came into the Moulton family's hands, it is inferred that Hugh Morville of the ½ moiety bequeathed the moiety to Ada Morville, or her heirs, at his death in 1269.³ Finally, we return to Joan de Morville - apparently the only child of Hugh Morville of the ½ moiety of Burgh - and her husband Sir Gerard de Furnival owner of Munden Furnival, Hertfordshire. As recorded above, they had five children between 1252 and 1264. One of those children, the fourth eldest, Alice de Furnival 1262-95, became the wife of Sir Thomas Foljambe, III, the father of the subject of this paper.

EARLY LIFE – Sir Thomas Foljambe IV was born ca.1284 in Tideswell, Derbyshire, the only child of Sir Thomas Foljambe III 1256-1323 and Alice de Furnival 1262-95. Thomas IV was born into a family that had been involved in county administration in both Normandy and, after 1066 AD, England, for over two centuries, including such positions as sheriffs, knights of the shires, Members of Parliaments (MP), Justices, etc., and he would be immersed in getting ready for his potential future role in any of these professions. It is reasonable to infer that, until age six, young Thomas IV spent most of his time within earshot of his mother, his Furnival aunts, or adult cousins, and perhaps elderly Foljambe ancestors such as Thomas II 1230-98. Developmentally, he could write his own name; say his full name, address, age, and birthday; draw a person with a head with eyes, mouth and nose, and a body with arms and legs; read a simple picture book.⁴ At age 6 Thomas IV would be expected to **begin** learning the non-martial side of knighthood basics: reading, writing, and arithmetic. By age 8, it was common for gentry eldest sons to be sent to the home of their family's *liege lord* for training, and ultimately, knighting. The Tideswell Foljambes' liege lord had been, until 1269, the Earl of Derby, a title then held by the Ferrers family. At the time of the *Conqueror* after 1066, Henry Ferrers had received large swaths of land as a gift from the King for his support and loyalty in the Norman war of 1066. In Derbyshire, Henry Ferrers received title to the area between the rivers Derwent and Dove, from the River Trent at Tutbury north to the Forest of the High Peak, an area called *Duffield Frith*.⁶ The Tideswell Foljambes' estates were inside the bounds of Duffield Frith. In 1269 a charge of treason related to Robert Ferrers, 6th Earl of Derby's role in the 2nd Barons' War had been adjudicated against him and his titles and estates were forfeited. Henry III ordered that Duffield Castle be pulled down and that the forfeited properties of the Earl of Derby be transferred to Henry III's 2nd eldest son, Edmund "Crux, or Crouch Back" Plantagenet 1245-96, whom Henry III had created 1st Earl of Lancaster, 1st creation. Thus, in 1269 the Tideswell Foljambes' liege lord became Edmund, 1st Earl of Lancaster.

SIR THOMAS FOLJAMBE IV, b. ca. 1284-d. ca. 1331 continued

It is inferred that in 1292, eight-year-old Thomas IV was taken by his parents to the home of the Earl of Lancaster, Kenilworth Castle, Kenilworth, Warwickshire, which Henry III had bequeathed to Earl Edmund in 1267.⁵ (see picture at left: the Ruins of Kenilworth Castle) At Kenilworth Thomas IV would have to succeed through several educational steps before being knighted: (1) military ability, chivalry, loyalty, generosity and social service; (2) Page – until age 14; (3) Squire – Apprentice of a knight, using and caring for horses, using and caring for a knight's armor and dress. The squire was usually knighted by his liege lord when the training was formally completed, he reached the minimum age of 21 and he owned a "knight's fee" of between 1,000 and 5,000 acres of land.^{7,3} According to Joseph Foster's Pedigree of Foljambe of Aldwarke Hall, Thomas IV was Knight of the Shire for



county Derby in 3 Ed.3 (1329) thus he had been knighted before 1329 and before his age 45. Based on the birth year of his eldest son, John, it is estimated that Thomas IV married his first wife in about 1304 at age 20 and it is reasonable to infer that he had completed his training, or at least left his training, by 1304. Foster shows further that Thomas IV's father died 17 Ed. 2 (1325) and Thomas IV succeeded to Tideswell and Wormhill 1 Ed. 3 (1326), making him eligible for knighthood by property ownership in 1326. Accordingly, it is reasonable to infer that Thomas IV was knighted in about 1 Ed 3 (1326) by his family's liege lord: (Edmund Crouchback 1st Earl of Lancaster had died 5 Jun 1296 and his titles and estates were inherited by his eldest son, Thomas, 2nd Earl of Lancaster; Thomas had died childless 22 Mar 1322 and his titles and estates were inherited by his eldest brother, Henry, 3rd Earl of Lancaster, who was still living in 1326.) Thus, the liege lord that finally knighted Thomas Foljambe IV in 1326 was Henry, 3rd Earl of Lancaster 1281-1345. (see picture at right) Henry had inherited Kenilworth Castle from his brother Thomas upon Thomas' death in 1322. It is inferred that Earl Henry chose Kenilworth as his home as his father and older brother had done before him. It is known that he spent the final 15 years of his life (1330-45) at Leicester Castle after he became blind in 1330. It is not believed, however, that he and Maud, his wife, abandoned Kenilworth 1322-1330. Thomas IV's knighting year of 1326 would place his age at his knighting to be 42 years. Joseph Foster's Pedigree of Foljambe does not show the death year of Thomas but an estimate can be deduced from the year that Thomas IV's senior heir succeeded to his estates. In that regard, John Foljambe, his eldest son, succeeded to the lordship of Tideswell and Wormhill on 4 Ed.3(1331). Thus, it is inferred that Sir Thomas Foljambe, IV, Knight of Tideswell & Wormhill, Derbyshire, died in, or shortly before, the year 1331.



MARRIAGES & CHILDREN - Sir Thomas IV married two times, the first time in ca. 1304 to Aveline de Weston (1289-1314), a co-heiress to the Weston-under-Lizard estates in Staffordshire with her elder brother, Thomas, and four younger sisters. By Aveline Sir Thomas sired three sons, John (b. 1305), Thomas (b. 1307), and Hugh (b. 1309.) John, the eldest son, was destined to become the Foljambe family patriarch upon Thomas IV's death. John's armored image in a brass and granite floor-slab, placed in the Tideswell parish church, remains today, and the historical record tells us that he founded a chantry at St. John the Baptist Church, Tideswell.⁸ (JOHN FOLJAMBE 1305-58 LORD OF TIDESWELL picture at right) The \$64,000 question concerning John is, "was he ever knighted?" He succeeded to the Lordship of Tideswell 4 Ed. 3 (1331) thus becoming the patriarch of the Foljambe family and inheriting several knight's fees in land at age 25. However, his tomb inscription on his memorial brass in St. John the Baptist, Tideswell makes no mention of knighthood and no documents have been found addressing him as "Sir" and "Knight." The answer to John's knighthood question remains obscure. Sir Thomas' second marriage, which occurred in 1315, was to Alice Darley (1298-1353), daughter of Robert de Darley (1261-1321) of Darley Nether Hall in Derbyshire and, by her, Sir Thomas sired one son, Sir Godfrey Foljambe, later Chief Justice of the Justiciar's Bench in Ireland. The Darleys had divided the original Darley estate into two moieties (two equal estates) in antiquity one manor surviving as Darley Old Hall the other as Darley Nether Hall. By Alice's time, the Old Hall moiety had been mortgaged and forfeited back to the Crown and although she was a potential heiress to Nether Hall, her brother had multiple issue that outlived her, making her an unlikely heir.⁹ Alice did not live to see the old Darley seat returned to her family, she died by 1353. . However, in 1358 her son, Sir Godfrey Foljambe, brought the Foljambe family into possession of the Darley Old Hall moiety by the serjeanty (performance of a special duty for king or country) of keeping Peveler's Castle and in November 1362 he purchased the Darley Old Hall moiety from the Crown and it was recorded with the provision that it be held and enjoyed for three lives, i.e., his own life, his wife Avena's life and his 3rd son Richard's life, before devolving to his "right heirs."
